REGULATION OF VESSELS – EXCLUSION ZONE & SPECIAL RESTRICTIONS

**Location (Regulated Area)**

Sydney Harbour – From Cockatoo Island to Steele Point, Vaucluse, comprising all navigable waters bounded by imaginary lines drawn between:

- Greenwich Point to Clarks Point (the entrance to the Lane Cove River); and
- Clarks Point, through to Cockatoo Island to White Horse Point; and
- Bradleys Head Light to Steele Point.

**Duration of Special Event**

- From 8:00pm Monday 30 December 2024 to 2:00am Wednesday 1 January 2025.

**Detail**

A fireworks display and lights parade to celebrate New Years Eve will be conducted on Sydney Harbour at the location specified above. Due to the potential to affect the safety of navigation, and to allow for the setting up of the fireworks equipment for the event, a **Regulated Area** with declared special restrictions will be established for the entirety of the location described above.

Pursuant to section 12(3) of the *Marine Safety Act 1998*, those **Special Restrictions** are as follows:

(a) From **8:00pm** (30 Dec 2024) to **1:00am** (1 Jan 2025) Jeffrey Street Wharf, Kirribilli will be closed to all vessels.

(b) From **8:00am** (31 Dec 2024) to **2:00am** (1 Jan 2025), anchoring of vessels in the areas which will become the Exclusion Zone later in the evening (as per attached map) and the following areas, is prohibited:

- a. Exclusion zone area
- b. Balmain East and Goat Island
- c. Lane Cove River entrance
- d. Balls Head
- e. Garden Island
- f. Bradleys Head channel

(c) From **10:00am** (31 Dec 2024) to **1:00am** (1 Jan 2025) McMahons Point ferry wharf will be closed to all vessels.

(d) From **11:30am** (31 Dec 2024) to **1:00am** (1 Jan 2025) Woolwich (Valencia Street) ferry wharf will be closed to all vessels.

(e) From **12:00pm** (31 Dec 2024) to **1:00am** (1 Jan 2025) Farm Cove will be restricted to vessels with a maximum length of 15 metres.

(f) From **3:00pm** (31 Dec 2024) to **1:00am** (1 Jan 2025) Milsons Point ferry wharf will be closed to all vessels.

(g) From **3:00pm** (31 Dec 2024) to **2:00am** (1 Jan 2025), minimum wash to be created and a maximum speed limit of 6 knots and is declared in the Regulated Area (unless otherwise authorised on site by Transport for NSW or Police).

(h) From **17:30pm** (31 Dec 2024) to **1:00am** (1 Jan 2025) Cremorne Point ferry wharf will be closed to all vessels.

(i) From **17:45pm** (31 Dec 2024) to **1:00am** (1 Jan 2025) Balmain East (Darling Street) ferry wharf will be closed to all vessels.

An **EXCLUSION ZONE** is specified during the event, which will be established inside the Regulated Area between 8:00pm Tuesday 31 December 2024 and 12:45am Wednesday 1 January 2025, and will be indicated by yellow lit buoys on the boundary (see the attached map).

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone, which will be patrolled by Police and Maritime vessels and monitored by other official control vessels.

Penalties may apply (Section 12(5) – *Marine Safety Act 1998*).

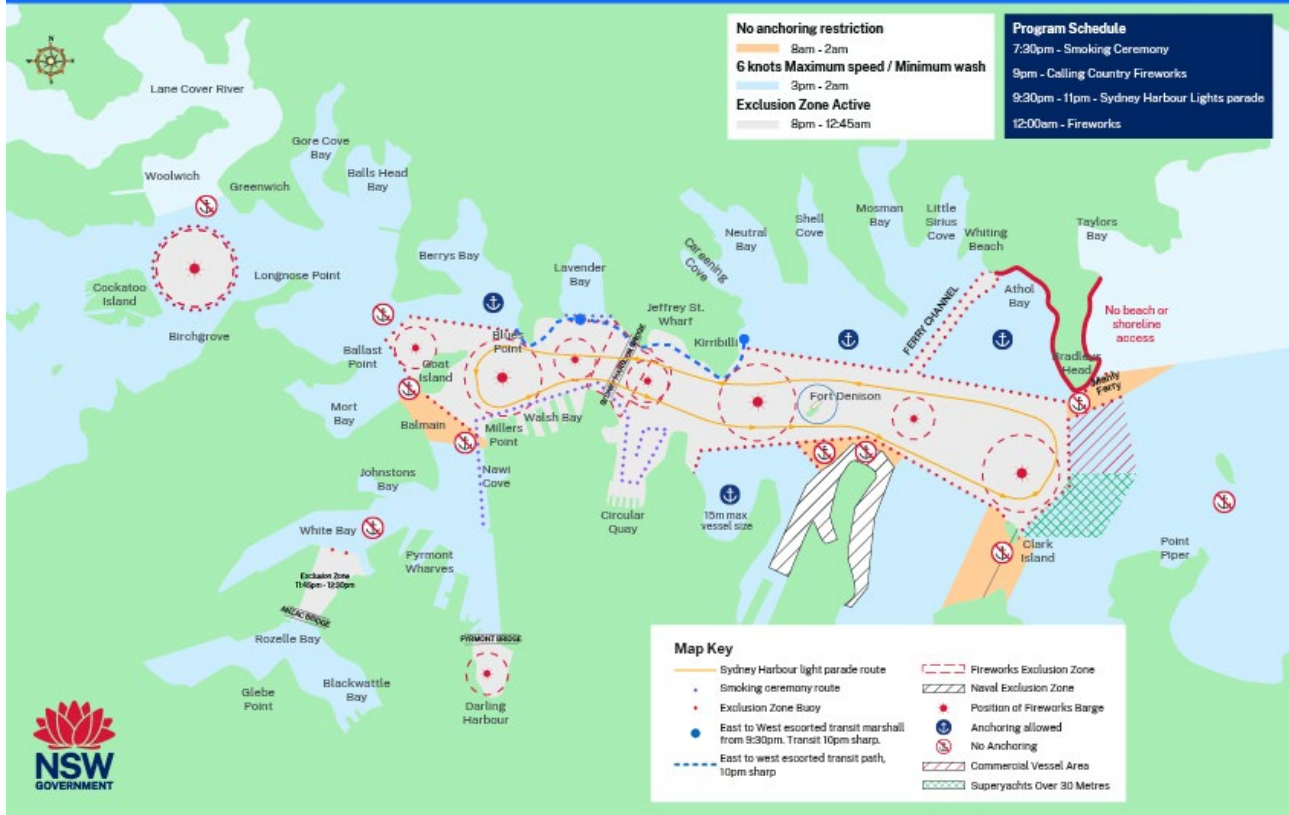

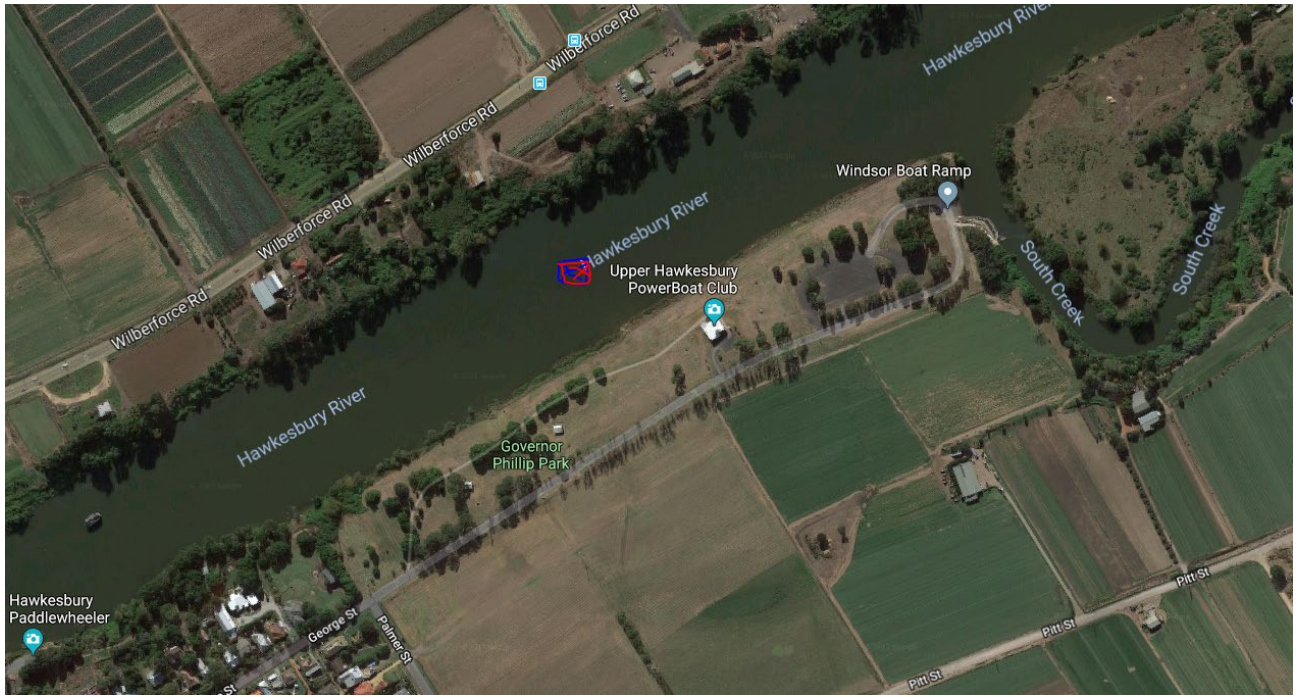

## ROAD TRANSPORT ACT 2013

**Ministerial (Farm Fire-Fighting Vehicles Exemption) Order 2024**

I, Jenny Aitchison, Minister for Regional Transport and Roads, pursuant to section 19(1) of the *Road Transport Act 2013*, make the following Order.

**Part 1 – Administrative****1 Citation**

This Order is the *Ministerial (Farm Fire-Fighting Vehicles Exemption) Order 2024*.

**2 Commencement**

This Order takes effect on and from 13 December 2024.

**3 Effect**

This Order remains in effect until 31 March 2025 unless revoked earlier.

**4 Interpretation**

Words and expressions used in this Order have the same meaning as in road transport legislation, unless otherwise stated.

**5 Definitions**

In this Order:

**Emergency fire-fighting incident** means an emergency due to an actual or imminent occurrence of a bush fire which—

- (a) endangers, or threatens to endanger, the safety or health of persons or animals, or
- (b) destroys or damages, or threatens to destroy or damage, property, or
- (c) causes a failure of, or a significant disruption to, an essential service or infrastructure.

**Farm Fire-Fighting Vehicle ('FFFV')** means any vehicle, including a trailer, with fire-fighting equipment permanently attached to the vehicle.

**FFFV nomination form** means the form submitted to Transport for NSW ('TfNSW') for participation in the FFFV Trial.

**FFFV Trial** means the trial scheme established by TfNSW for the exemption in this Order.

**Fire-fighting equipment** means equipment used for or in connection with the prevention or suppression of fire or the protection of life or property in case of fire.

## Part 2 – Exemption Details

### 6 Road Transport Legislation Exemption

Subject to the conditions at clause 7 of this Order, persons driving or using an FFFV on road and road-related areas are exempt from section 68(1) of the *Road Transport Act 2013* and section 60(1)(b)(i) of the *Road Transport (Vehicle Registration) Regulation 2017* when responding to or returning from emergency fire-fighting incidents.

### 7 Conditions

7.1. FFFVs are equipped with fully functioning indicators and brake lights.

7.2. Unless the FFFV is a trailer, the FFFV is also equipped with fully functioning:

- (a) mirrors, including a rear vision mirror, driver's side mirror and passenger's side mirror, and
- (b) headlights, and
- (c) seatbelts in the seating positions for the driver and passengers that are conveyed in the vehicle.

7.3. The FFFV is nominated as part of the FFFV Trial and has been declared as suitable for safe use and in a thoroughly serviceable condition by completion and submission of a FFFV nomination form to TfNSW.

7.4. Persons driving or using the FFFV produce to NSW Police or an Authorised Officer a copy of the completed TfNSW FFFV nomination form and notification from TfNSW that the vehicle has been accepted into the FFFV trial if requested.

7.5. The FFFV is only used or driven within a 100km radius of the storage address where the FFFV is normally kept, as stated on the FFFV nomination form.

7.6. The FFFV does not display a number plate.

### Explanatory Note

This Order authorises unregistered vehicles to be used on NSW roads during emergency bush fire incidents for the 2024-2025 fire season.

**Location (regulated area)**

Sydney Harbour - Garden Island to Sydney Heads as follows:

All navigable waters bounded by imaginary lines drawn between:

- Garden Island Port Hand Beacon and Bradley's Head Light.
- the most northerly point of Middle Head, and Cannae Point Flagstaff.
- North Head starboard hand beacon and Macquarie Light.

**Duration**

- 11:30am to 2:20pm - Thursday 26 December 2024.

**Special Event**

A special event, being the 2024 Rolex Sydney Hobart Yacht Race, will take place on Sydney Harbour at the above location in a regulated area, as detailed on the attached map,

Due to the potential to affect the safety of navigation and for the amenity of users of the specified waters, special restrictions will be established in the regulated area as follows

Pursuant to section 12(3) of the *Marine Safety Act 1998*, those special restrictions are as follows:

- No sail vessel other than official competing yachts may have sails hoisted between 12:00pm and 2:20pm;
- A strict 6 knot speed limit zone for the duration;
- A "no wash" zone for the duration; and
- No anchoring or passive craft in the area marked by red stripes in the attached map. NO VESSELS are permitted to anchor in this area *under any circumstances* and, due to the safety risks posed by the event and by spectator vessel traffic, NO UNPOWERED VESSELS ('passive craft', such as canoes, kayaks, surf boats, paddleboards, surf skis, rowing craft) are permitted in this area at any time.

## **Exclusion Zone**

In addition, an Exclusion Zone will be established inside the Regulated Area between 12:00pm and 2:20pm, which will be marked by a perimeter of yellow buoys, and as indicated with a red border on the attached map

NO UNAUTHORISED VESSELS are to enter the Exclusion Zone, which will be patrolled by Transport for NSW (Maritime) patrol vessels, Water Police, and Marine Rescue vessels.
