Act No. 1, 2024 – An Act to amend the Constitution Act 1902 in relation to meetings of the Executive Council. [**Constitution Amendment (Executive Council) Bill 2024**]

Act No. 2, 2024 – An Act to amend the Centennial Park and Moore Park Trust Act 1983 in relation to licensing of trust lands for use for public transport and ancillary purposes. [**Centennial Park and Moore Park Trust Amendment (Public Transport) Bill 2024**]

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 3 — An Act to amend various Acts relating to crime and criminal procedure. **[Crime and Criminal Procedure Legislation Amendment Bill 2024]**

Act No. 4 — An Act to amend the Charitable Fundraising Act 1991 and the Associations Incorporation Act 2009 in relation to registered entities; to amend the Retail Leases Act 1994 in relation to Western Sydney Airport; and to amend the Property and Stock Agents Act 2002 and the Property and Stock Agents Regulation 2022 in relation to certificates of registration. **[Customer Service Legislation Amendment Bill 2024]**

Act No. 5 — An Act to amend various Acts relating to the detention of persons to prohibit the use of spit hoods. **[Detention Legislation Amendment (Prohibition on Spit Hoods) Bill 2024]**

Act No. 6 — An Act to amend the Crimes (High Risk Offenders) Act 2006 and the Terrorism (High Risk Offenders) Act 2017 for particular purposes. **[High Risk Offenders Legislation Amendment Bill 2024]**

Act No. 7 — An Act to amend various Acts relating to institutions in New South Wales. **[Institutions Legislation Amendment Bill 2024]**

Act No. 8 — An Act to make miscellaneous amendments to the Sheriff Act 2005 and Court Security Act 2005, including in relation to the functions of the Sheriff and the powers of sheriff's officers. **[Sheriff and Court Security Amendment Bill 2024]**
