ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 25 March 2024

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 12 — An Act to amend the *Environmental Planning and Assessment Act 1979* to prohibit the carrying out of sea bed petroleum and mineral exploration and recovery and related development; and for related purposes. **[Environmental Planning and Assessment Amendment (Sea Bed Mining and Exploration) Bill 2024]**

Act No. 13 — An Act to amend the *Human Tissue Act 1983* to allow ante-mortem procedures to be carried out to facilitate post-mortem tissue donation; and for related purposes. **[Human Tissue Amendment (Ante-mortem Interventions) Bill 2024]**

IT is hereby notified, for general information, that Her Excellency the Governor has, in the name and on behalf of His Majesty, this day assented to the undermentioned Acts passed by the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, viz.:

Act No. 9, 2024 – An Act to amend the *Animal Research Act 1985* to prohibit the carrying out of forced swim tests and animal research in which an animal is forced to inhale smoke; and for related purposes. [**Animal Research Amendment (Prohibition of Forced Swim Tests and Forced Smoke Inhalation Experiments) Bill 2023**]

Act No. 10, 2024 – An Act to amend the *Protection of the Environment Operations Act 1997* to implement national reforms to the management of certain chemicals; and for related purposes. [**Environmental Legislation Amendment (Hazardous Chemicals) Bill 2024**]

Act No. 11, 2024 – An Act to amend the *Electoral Funding Act 2018* to make further provision regarding capped local government expenditure periods and local government election campaign electoral expenditure caps; and for other purposes. [**Electoral Funding Amendment (Local Government Electoral Expenditure Caps) Bill 2024**]
