MENTAL HEALTH ACT 2007
Section 109
Declaration of Mental Health Facility

I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:

a) DECLARE the following premises of **Tweed Valley Hospital**, 771 Cudgen Road, Cudgen NSW 2487 to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:

Tweed Valley Hospital Emergency Department, located on the Lower Ground Level of A Block; and

b) DECLARE this facility to be designated in the "**mental health emergency assessment**" class of facilities; and

c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:

- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3.

Section 109
Declaration of Mental Health Facility

I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:


a) DECLARE the **Tweed Community Mental Health Service**, located on the Lower Ground Floor of B Block, Tweed Valley Hospital, 771 Cudgen Road, Cudgen NSW 2487, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*; and

b) DECLARE this facility to be designated in the "**community or health care agency**" class of facilities; and

c) RESTRICT this facility to the provision of services and performance of functions necessary for, or associated with, the administration or management of community treatment orders, under the following provisions of the *Mental Health Act 2007*:

- i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
- ii. Chapter 4; and
- iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2).
