REGULATION OF VESSELS – EXCLUSION ZONE

Location

Milsons Point and Campbells Cove, Port Jackson.

Duration

- 5:30pm to 6:15pm – Friday 24 May 2024

Detail

A fireworks display will be conducted from a barge east of Milsons Point and from the Ships Dolphin in Campbells Cove, Port Jackson.

An **EXCLUSION ZONE** is specified during the event, 125m around the fireworks barge at Milsons Point and 50m around the Ships Dolphin in Campbells Cove (as per the attached map). The Exclusion Zone will be indicated by the presence of Maritime patrol vessels and other control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the above times.

Penalties may apply (Section 12(5) - *Marine Safety Act 1998*).
