## LIQUOR ACT 2007

Declaration of special event extended trading for events of regional, State or national significance

# **Schedule 1: Special Events and Related Conditions**

#### **Guidance notes**

- 'Eligible licence types include Hotels, General Bars, Clubs, Small Bars and Dedicated Live Music & Performance Venues.
- Special event means an event the Minister considers to be of regional, State or national significance.
- Midnight, in relation to a particular day, means the point of time at which that day ends.

| Champions<br>League final<br>(Football) | 4am to 5am on Sunday 2 June 2024                              | Only licensed premises to which a small bar licence, general bar licence, a hotel licence or a club licence relates, showing a live broadcast of the match. |
