REGULATION OF VESSELS - EXCLUSION ZONE

Location

Lake Macquarie – adjacent to Toronto, Belmont and Warners Bay foreshore reserves.

Duration

- 5:00pm to 7:30pm Friday 21 June 2024
- 5:00pm to 8:30pm Saturday 22 June 2024

Detail

A flotilla display will be conducted over the navigable waters of Lake Macquarie, Toronto on Friday 21 June 2024, and Belmont and Warners Bay on Saturday 22 June 2024. The event will involve a display of brightly lit vessels transiting through the above areas.

An **EXCLUSION ZONE** is specified during the event, which will be marked with buoys and lights at the locations specified above. The Exclusion Zone will be monitored by control vessels stationed around the perimeter.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) – Marine Safety Act 1998).

ROAD TRANSPORT ACT 2013 ORDER

Section 45

I, Simon Brodie, Senior Manager Licence Operations, a delegate of Transport for NSW, pursuant to section 45 of the *Road Transport Act 2013*, by this Order, approve the type of interlock device specified below as an *approved interlock device*:

Type of device:

The interlock device Smart Start Ignition SSI 20/35 (also known as SSI-20/35) and the interlock device Smart Start Ignition SSI 20/35 (also known as SSI2035) with Smart Start G5 camera installed as a component of the device.

Explanatory Note:

Section 45 of the *Road Transport Act 2013*, provides that a type of 'approved interlock device' (designed to analyse a breath sample for the presence of alcohol and prevent a motor vehicle from being started if it detects more than a certain concentration of alcohol) requires approval by Transport for NSW by order published in the Gazette.

This Order specifies the Smart Start Ignition SSI 20/35 (also known as SSI-20/35) and the interlock device Smart Start Ignition SSI 20/35 (also known as SSI2035) with Smart Start G5 camera installed as a component of the device - as a type of 'approved interlock device'.
