Explanatory note

The Transport Asset Holding Entity of New South Wales (TAHE) will transition to a non-commercial Public non-Financial Corporation (PNFC). The purpose of this Direction is to ensure NSW has an optimal model for delivering transport services while providing for focused and strategic asset management and assurance, , and its investment in rail assets.

The Direction is the result of exceptional circumstances and in the public interest because:

- The government has decided to transition TAHE from operating as a statutory State Owned Corporation to operating as a PNFC.
- Under a non-commercial operating model, TAHE is no longer required to earn a commercial return which will enable longer term investments in rail assets, the Transport network and social objectives (such as responding to the current housing crisis in NSW).
- The Board of TAHE is directed to ensure that TAHE takes on a mix of cash and debt as agreed with NSW Treasury and subject to necessary approvals under the GSF Act, to fund the additional projects as outlined in section 3.

1 Name of Direction

This direction is the *Direction to the Board of the Transport Asset Holding Entity of New South Wales (Capital Program, Cash Balances, Borrowings and Access/License Fees)* 2024.

2 Commencement

This direction commences on the day on which it is signed and will remain in force until it is revoked.

3 TAHE Capital Program

The Board of the Transport Asset Holding Entity of New South Wales (**TAHE**) is directed, in a timely manner, to make additions to TAHE's financial year 2024-25 10-year capital program, and implement all necessary changes, to give effect to the following in relation to funding and programming of capital works owned by TAHE.

Additions to the 10-year capital program include:

- Tangara Fleet Life Extension Project \$435.5 million
- Strategic Business Case for the Future Fleet Program \$11.5 million
- Digital Train Radio System \$25.0 million

(together, the "Additional Capital Projects").

4 Financing of Additional Capital Projects

The Board of TAHE is directed to fund the Additional Capital Projects from existing cash balances up to 2025-26 and by taking on additional borrowings to be incurred from 2026-27 onwards, and for servicing costs to be funded from existing and future cash balances.

Additional borrowings are to be drawn down as required (currently anticipated at \$197 million) and subject to the necessary approvals under the *Government Sector Finance Act 2018*.
