REGULATION OF VESSELS - EXCLUSION ZONE

Location

Nepean River – Penrith, between Penrith Weir and upriver to Euroka Creek (see attached map).

Duration

7:00am to 3:00pm – Sunday 21 July 2024

Detail

Paddleboard races will be conducted on the navigable waters of the Nepean River as specified above.

An **EXCLUSION ZONE** is specified during the event which will be indicated by buoys and monitored by control vessels (see attached map).

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (section 12(5) – Marine Safety Act 1998).
