MARGARET BEAZLEY, Governor

I, the Honourable Margaret Beazley AC KC, Governor of New South Wales, with the advice of the Executive Council, and in pursuance of sections 256 and 736 of the *Local Government Act 1993*, do, by this Proclamation amend the Proclamation which declared all civic offices of Central Darling Shire Council to be vacant and which was published in Government Gazette No 103 of 14 November 2014 (as amended by Proclamations published in Government Gazette No. 117 of 4 October 2019 [n2019-3031] and No 232 of 1 June 2022 [n2022-0938]) by omitting paragraph (c) and inserting instead-

- (c) order that the term of the Administrator commences immediately and ceases on the date of the Council's fresh election to be held on 15 March 2025.
