REGULATION OF VESSELS - EXCLUSION ZONE

Location

Coral Sea, near Fingal Head – within 600m of Cook Island

Duration

5:30am to 6:30pm on the following dates:

Friday 2 August to Friday 9 August 2024

Detail

A film shoot involving the use of aerial drones will be conducted over the navigable waters of the Coral Sea at the location specified above, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will be established on the waters of the Coral Sea for a 600m perimeter around Cook Island. The Exclusion Zone will be monitored by control vessels. Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the above times.

Penalties may apply (section 12(5) - Marine Safety Act 1998).

REGULATION OF VESSELS - EXCLUSION ZONE

Location

Manning River, Taree – between Martin Bridge and Dumaresq Island

Duration

7:00am to 5:00pm - Sunday 4 August 2024

Detail

Powerboat racing will be conducted on the navigable waters of the Manning River, as specified above. The event will involve the use of powered vessels operating at speed, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be indicated and monitored by the presence of control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) – Marine Safety Act 1998).

Transiting Vessels

Provision has been made for vessels to transit the Exclusion Zone during breaks in the trials. Control vessels may, at times during the trials, authorise vessel traffic to pass through the Exclusion Zone.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Blowering Dam, Tumut

Duration

8:00am to 4:00pm on the following dates:

- Saturday 3 August 2024
- Sunday 4 August 2024

Detail

Trials involving the use of a high speed vessel powered by a jet engine will be conducted on the waters of Blowering Dam as specified above. The jet powered vessel will be operating at very high speed and will present a significant potential hazard to other waterway users. There will be support and official vessels present to manage the trials.

An **EXCLUSION ZONE** is specified during the event, which will comprise of the entirety of Blowering Dam, and will be monitored by Maritime vessels.

At varying times between trials, such as when the jet powered vessel is not being operated, Maritime officers on-site may lift the Exclusion Zone to allow boaters to use the waterway for periods of time.

Other than during these interim periods, unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) – Marine Safety Act 1998).
