All lease areas will be tendered in an "as is" condition. Any existing improvements (including cultivation materials, lease markings and structures) present within the lease areas have not been valued and will become the responsibility of the successful tenderer(s).

Following the granting of the lease areas, an inspection by a Fisheries Officer will be completed and a Notice to Comply may be issued for the removal of any improvements.

Any unauthorised structures present on the area will require removal by the successful tenderer(s) or authorisation by the relevant authority.

For the lease areas located in Port Stephens – Great Lakes Marine Park, the permit holder may be required to apply for a Marine Parks work permit before placing any cultivation material on the lease areas.

All leases offered within this tender will require a lease plan be produced by a registered surveyor unless specifically stated otherwise. All surveys are to be conducted at the expense of the successful tenderer(s).

Any lease granted as a result of the tender will be subject to standard covenants and conditions of an aquaculture lease and aquaculture permit, as prescribed under the *Fisheries Management Act 1994*, including payment of annual fees and charges. Special conditions may also be applied. The lease and permit conditions that may be applied can be found in the Request for Tender document.

Lease rent is charged annually, currently at \$60 per hectare (excl. GST), which is subject to an annual Consumer Price Index adjustment. Tenure of a lease will be up to 15 years.
