Vocational Training Order

1. The following apprenticeship vocations are designated:

- Engineering-Fabrication Trade (Blacksmithing)
- Engineering-Fabrication Trade (Boilermaking)
- Engineering-Fabrication Trade (Boilermaking/Welding)
- Engineering-Fabrication Trade (Sheetmetal working)
- Engineering-Fabrication Trade (Surface finishing)
- Engineering-Fabrication Trade (Welding)

2. This Order will take effect from the date of publication in the NSW Government Gazette.



Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to **Wollongong City Council** to advertise and recruit for:

- a 6-week summer work pilot Parks & Open Space program with six places designated for Aboriginal and Torres Strait Islander students and six for female students only
- one summer traineeship (horticulture) for a female student only.

This exemption will remain in force for 3 years.
