Urbane Street Leonay intersection to the eastern boundary of 113-116 River Road, Emu Plains, originally held in Conveyance Book 1809 Number 861.

River Road, Emu Plains from the eastern boundary of 94A Nepean Street, Emu Plains approximately 16 metres heading east, originally held Conveyance Book 1826 Number 144 (part portion 110).


River Road, Emu Plains from 94A Nepean Street to the western boundary of 107 River Road, Emu Plains, originally held in Conveyance Book 1826 Number 144 (part portions 127,128 &129).

River Road, Emu Plains from the western boundary of 104 River Road to the eastern boundary of 93 River Road, Emu Plains, originally held in Conveyance Book 1811 Number 31.

River Road, Emu Plains from the western boundary of 92 River Road to the eastern boundary of 84-88 River Road, Emu Plains, originally held in Conveyance Book 1849 Number 858.

River Road, Emu Plains from the western boundary of 83 River Road to the eastern boundary of 82 River Road, Emu Plains (intersection of River Road and Hunter Street), originally held in Conveyance Book 1801 Number 528.
