Section 12(2)

REGULATION OF VESSELS – SPECIAL RESTRICTIONS

Location

Williams River – downstream from Clarence Town (various locations).

Duration

Monday 23 September 2024 to Friday 20 December 2024.

Detail

Riverbank stabilisation works will involve the mobilisation and placement of barges, work vessels, machinery and equipment, including land and water based heavy lifting equipment and vessel operations within the waterway.

Special Restrictions

A temporary **4 knot speed restriction zone** ('the Zone') will be established on the navigable waters of the Williams River, comprising the entire width of the river from approximately 60 metres upstream to approximately 60 metres downstream of the works.

The Zone will be clearly marked by localised signage and yellow special mark aqua buoys.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

The swim leg of a triathlon event will be conducted on the navigable waters of the Minnamurra River as specified above.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of large inflatable buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the time above.
