Notice under section 42(1) of the *Fisheries Management (Aquaculture) Regulation 2024*Proposed public tender of aquaculture lease in the Richmond River

Department of Primary Industries and Regional Development (DPIRD) is intending to offer by public tender one area of public water land in the Richmond River, for the purpose of aquaculture.

The lease area is not classified as a priority oyster aquaculture area under the State Environmental Planning Policy (Primary Production) 2021. As such, any applicant for the lease area will be required to obtain landowner's consent from Crown Lands and development consent from the local Council following the tender process.
