REGULATION OF VESSELS – EXCLUSION ZONE

Location

Tomaga River – The entire width of the river between the entrance to the estuary at Mossy Point, where the Tomaga River meets the Tasman Sea, upstream for approximately 2.5 kilometres to the Tomaga Bridge.

Duration

• 8:00am to 12:00pm – Saturday 1 February 2025.

Special Event

The swim leg of various triathlon races will be conducted on the navigable waters of the Tomaga River as specified above.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of large inflatable buoys on the boundary and monitored by control vessels.

Unauthorised vessels and persons are prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).



ROAD TRANSPORT ACT 2013 - ORDER

The Honorable Margaret Beazley AC KC, Governor.

I, the Honorable Margaret Beazley AC KC, Governor of the State of New South Wales, with the advice of the Executive Council, and pursuant to the *Road Transport Act 2013* (the Act), do, by this Order, approve the type of traffic enforcement device named in Schedule 1 as being designed for the use of:

- 1. **speed measurement**, designed to measure the speed at which a vehicle is travelling in accordance with the terms of section 134(1)(a) of the Act;
- 2. **excess speed imaging**, designed to photograph a vehicle that is being driven in excess of a speed limit applicable to a length of road in accordance with the terms of section 134(1)(b) of the Act.

REGULATION OF VESSELS - EXCLUSION ZONE

Location

Lake Talbot, Narrandera – the body of water extending from Lake Talbot Swimming Pool Complex up to the mud-bank opposite Snake Island.

Duration

6:00am to 8:00pm on the following dates:

- Thursday 30 January 2025.
- Friday 31 January 2025.
- Saturday 1 February 2025.
- Sunday 2 February 2025.

Special Event

A competitive water ski tournament will be conducted on the navigable waters of Lake Talbot as specified above. The event will involve the use of high-speed power vessels, persons being towed at speed using towlines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be monitored and indicated by the presence of event staff and control vessels on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) - Marine Safety Act 1998)
