POISONS AND THERAPEUTIC GOODS ACT 1966 EXEMPTION ORDER ISSUED UNDER SECTION 34 SUPPLY OF THERAPEUTIC GOODS IN A PUBLIC PLACE

Pursuant to section 34 (3) of the Poisons and Therapeutic Goods Act 1966, I, Dr Kerry Chant, Chief Health Officer, a duly appointed delegate for the Minister for Health, do hereby exempt the supply of condoms at certain public events from the operation of section 34 (1) of the Poisons and Therapeutic Goods Act prohibiting the supply of therapeutic goods in a public place.

This Order is subject to the following conditions:

- a) The condoms are included in the Australian Register of Therapeutic Goods (ARTG).
- b) The person supplying the condoms must notify the Ministry of Health of the intention to supply condoms at a public event no less than seven days prior to the public event occurring.
- c) The product must be offered only to persons at least aged 18 years of age.
- d) The product must be supplied only in the original ARTG packs (including batch numbers and expiry dates) labelled and packaged as approved by the Commonwealth Therapeutic Goods Administration (TGA).
- e) The product must be personally handed to each recipient.
- f) The supply must be carried out in a manner that enables each intended recipient to be fully aware that the product is being offered before making an informed decision whether to accept the offer of the pack.
- g) The supply must be carried out in a manner that does not cause offence to any person nor occasion any disturbance to public order or safety.
- h) This Order remains in force until 31 December 2026 or until earlier revoked.

POISONS AND THERAPEUTIC GOODS REGULATION 2008

ORDER

Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008*, the Order that took effect on and from **17 March 2017** served on **Dr John Bernard Sivewright (MED0000970333)** of Bass Hill NSW 2197, prohibiting him as a medical practitioner, from supplying, having possession of or issuing a prescription for a drug of addiction as authorised by clauses 101 and 77 of the Regulation, shall cease to operate on and from 30 January 2025.
