A special event involving an aerial stunt from a helicopter will be conducted between Mrs Macquarie's Chair to Sydney Cove, inclusive of Farm Cove, Port Jackson, as specified above.

An **EXCLUSION ZONE** is specified during the event (as per the below map), which will be patrolled and indicated by the presence of Maritime control vessels on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Hawkesbury River - Windsor Reach, Windsor adjacent Governor Phillip Park.

#### Duration

7:00am to 5:00pm on the following dates:

- Tuesday 25 February 2025
- Wednesday 26 February 2025
- Thursday 27 February 2025
- Friday 28 February 2025
- Saturday 1 March 2025

#### **Special Event**

A wakeboarding tournament will be conducted on the waters of Hawkesbury River as specified above.

An **EXCLUSION ZONE** is specified during the event which will run adjacent to Governor Phillip Park for approximately 700m as per the attached map. The Zone will be indicated by buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the above dates and times.

## REGULATION OF VESSELS – EXCLUSION ZONE & SPECIAL RESTRICTIONS

#### Location

Edward River – near the Deniliquin Boat Club on Riverview Drive, Deniliquin:

- Upstream 400 metres of the Deniliquin Boat Club and adjacent to the Big 4 Deniliquin Holiday Park, to
- Downstream 400 metres of the Deniliquin Boat Club and adjacent to the Warbreccan Homestead.

#### Duration

On the following dates and times:

- 7:00am to 7:00pm Saturday 15 February 2025.
- 7:00am to 7:00pm Sunday 16 February 2025.

#### **Special Event**

A wakeboarding competition will be conducted on the navigable waters of the Edward River as specified above. The event will involve the use of powered vessels, persons being towed at speed using tow-lines and persons in the water, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by buoys, monitored by control vessels and patrolled by NSW Maritime vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

#### Transit Lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'Transit Lane'.

#### **Special Restrictions**

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, the following special restrictions are applicable to all vessels operating in the Transit Lane:

• Maximum speed limit of 4 knots, and

• Minimal wash must be produced.

Penalties may apply (Section 12(5) - Marine Safety Act 1998)

## **REGULATION OF VESSELS – SPECIAL RESTRICTIONS**

#### Location

Murray River – near Albury, from the Hume Dam Wall downstream to Noreuil Park.

#### Duration

On the following dates and times:

- 2:00pm to 8:00pm Saturday 15 February 2025.
- 9:00am to 3:00pm Sunday 16 February 2025.

#### **Special Event**

A canoe and kayak event will be conducted on the navigable waters of the Murray River as specified above.

Due to the risk to safe navigation and as a result of the nature and number of participating vessels, a Regulated Area with special restrictions is specified between the above times comprising the full width of the Murray River at the location specified above, extending 200 metres ahead and 200 metres to the stern of the competing vessels.

#### **Special Restrictions**

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to powered vessels operating in the Regulated Area:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

# Nambucca Valley Council Area

# Dedication of Land as Public Road and Declaration of an Access Point to a Controlled Access Road at Congarinni and Eungai Creek



#### REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

#### **Regulated Area**

Sydney Harbour –all navigable waters bounded by imaginary lines drawn between:

- Garden Island to Robertson Point, Cremorne; and
- Georges Head, Mosman to Laings Point, Vaucluse

#### Duration

Tuesday 4th February 2025 to Monday 10th February 2025.

#### Special Event

SailGP will take place on the navigable waters of the regulated area as specified above. To ensure the safety of navigation, Special Restrictions will be in place within the regulated area for the period specified above and an Exclusion Zone is established at designated times during the event.

#### **Exclusion Zone**

An **EXCLUSION ZONE** will be established at the below designated times in the regulated area, which will be marked by yellow inflatable buoys (as per the attached map) and will be patrolled by Police, Maritime and Marine Rescue vessels:

- Friday, 7 February 2025 12:00pm to 3:00pm.
- Saturday, 8 February 2025 2:00pm to 5:00pm.
- Sunday, 9 February 2025 2:00pm to 5:00pm.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the specified times.

An additional line of inflatable yellow buoys outside the Exclusion Zone between Neilsen Park and Hermit Bay will mark a navigable channel (as per the attached map).

#### **Special Restrictions**

Pursuant to section 12(3) of the Marine Safety Act 1998, the following **Special Restrictions** apply to vessels operating in the Regulated Area:

- Vessels are not permitted to anchor within 200 metres of a submerged fibre optic cable, which will run between Shark Island, Woollahra Point and Rose Bay (as per the attached map) and will be marked at either end by inflatable buoys.
- During Exclusion Zone times minimum wash is to be created and a maximum speed limit of 6 knots applies to all vessels within 200m of the Exclusion Zone.
- During the Exclusion Zone times vessels must not stop, drift or anchor in the navigable channel, or within the following areas (as per the attached map):
  - between Neilsen Park and Hermit Bay;
  - North of Point Piper;
  - South of Bradleys Head;
  - in the vicinity of Georges Head.
- During the Exclusion Zone times vessels are not permitted to anchor on the western boundary of the Exclusion Zone between Clark Island and Bradleys Head (as per the attached map).

## **Offence Provision**

Transport for NSW advises that any vessel operator or person

- breaching the Special Restrictions detailed above; or
- entering the Exclusion Zone

may be liable to an offence (*Marine Safety Act 1998 s.12(5)* - Maximum Penalty \$1,100.00)
