Offshore Minerals Act 1999 – Instrument of Delegation (Minister) 2024

I, the **Hon. Courtney Houssos MLC**, Minister for Natural Resources, make this Instrument of Delegation under section 439(1) of the *Offshore Minerals Act 1999*.

1. Delegation of functions

- (1) All functions of the Minister under the Act, the Regulation, and any instrument, licence, consent or notice made under the Act or Regulation, including any conditions imposed in relation to such instrument, licence, consent or notice are delegated to a person in one of the following roles:
 - (a) Secretary,
 - (b) Deputy Secretary, NSW Resources, or if that role no longer exists, senior executive band (SEB) 3 role responsible for supporting the administration of the Act.
- (2) In addition to (1), the functions of the Minister under the Act and the Regulation specified in Column 1 of Schedule 3 are delegated to any person in the delegate level specified in Column 2 of Schedule 3.

2 Interpretation

This instrument is to be interpreted in accordance with Schedule 1.

3 Commencement

This Instrument commences on the date it is signed.

4 Revocation

- (1) The following delegations are revoked:
 - (a) Instrument of Delegation (*Offshore Minerals Act 1999 – Minister*) 2020.
 - (b) Offshore Minerals (Compliance and Enforcement) Instrument of Delegation 2021.
- (2) Except as specified in clause 4(1), this delegation is in addition to, and is not intended to revoke or limit, the delegation of functions by any other instrument of delegation that is in force.

- (1) “**delegate level**” means the levels described in Column 1 of Schedule 2.
- (2) “**function**” includes a power, authority or duty, and “exercise” a function includes perform a duty.
- (3) “**Department**” means the Department of Primary Industries and Regional Development.
- (4) “**public service senior executive**” has the same meaning as in the *Government Sector Employment Act 2013*.
- (5) “**public service senior executive band**” (**SEB**) has the same meaning as in the senior executive bands determination made under the *Government Sector Employment Act 2013*.
- (6) “**role**” includes office, and a person “assigned” to a role includes the “holder” of an office. A reference to a role includes any person who is for the time being assigned to the role, or performing the duties and responsibilities of the role.
- (7) “**the Act**” means the *Offshore Minerals Act 1999*.
- (8) “**the Regulation**” means the Offshore Minerals Regulation 2020.
- (9) Unless otherwise specified, references to a role are references to a role within the Department.
