Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to **New South Wales Energy Coal (the BHP Group)** to advertise, recruit and prioritise roles for women only and to offer programs, activities and events to attract, develop, engage and support career growth for women in pursuit of its targets of 30.8% female representation overall and 34.9% female leadership representation within its operations at the Mt Arthur coal mine.

This exemption will remain in force for **2 years**.
