## SUBORDINATE LEGISLATION ACT 1989

## Notice of consultation on a proposal to make the Motor Vehicles Taxation Regulation 2025

Notice is hereby given, under section 5(2)(a) of the *Subordinate Legislation Act 1989*, that Transport for NSW is seeking public submissions on a proposal to make the Motor Vehicles Taxation Regulation 2025.

The proposed new regulation would replace an existing regulation which is due to be automatically repealed on 1 September 2025.

The object of the proposed regulation is to remake all the necessary provisions of the existing regulation, with amendments to ensure the regulatory framework remains effective and up to date. This includes:

- the tax refund on surrender of registration will be calculated on days used
- a 40 per cent tax reduction for privately used caravans
- specifying how to determine the unladen mass of a vehicle
- a tax based on vehicle type, characteristics and unladen mass
- the tax for tractors capped
- additional tax for certain vehicles over 3,560 kg
- increasing the tax each year in line with the Consumer Price Index (CPI).

Key updates of the proposed regulation will:

- provide certainty for the community by formalising "undocumented" tax concessions, and
- reduce administration costs for Government by simplifying CPI arrangements and streamlining the regulatory framework.

## Section 12(2)

## **REGULATION OF VESSELS – EXCLUSION ZONE**

#### Location

Lake Jindabyne near the township of Jindabyne – all navigable waters adjacent to Banjo Paterson Park extending from the foreshore in a rectangle shape for approximately 500 metres into lake Jindabyne.

## Duration

6:30am to 6:30pm on the following dates:

- Saturday 15 February 2025.
- Sunday 16 February 2025.

## Special Event

A wakeboarding tournament will be conducted on the navigable waters of Lake Jindabyne as specified above. The event will involve the use of powered vessels, persons being towed at speed using tow-lines and persons in the water, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by a series of buoys, monitored by control vessels and patrolled by NSW Maritime vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) - Marine Safety Act 1998)

## **REGULATION OF VESSELS – EXCLUSION ZONE**

#### Location

Currambene Creek and Jervis Bay, Huskisson - all navigable waters of Currambene Creek and Jervis Bay within a 100m radius of the northeastern end of Voyager Park.

#### Duration

• 8:30pm to 9:30pm – Saturday 22 February 2025.

#### **Special Event**

A fireworks display will be conducted over the navigable waters of Currambene Creek and Jervis Bay as specified above. The waterway directly around the firing location may be dangerous and hazardous to waterway users.

An **EXCLUSION ZONE** is specified during the event, which will extend 100m around the display, which will be indicated by the presence of control vessels stationed on the boundaries.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

Jervis Bay – Near the township of Huskisson and Callala Beach

- Wednesday, 19 February 2025 in the waters of Jervis Bay along the shoreline of Callala Beach, as marked by buoys.
- Friday, 21 February 2025, Saturday, 22 February 2025 and Sunday, 23 February 2025 in the waters of Jervis Bay near the township of Huskisson, between the southern side of the Currambene Creek entrance and Tapalla Point, as marked by buoys.

## Duration

On the following dates and times:

- Wednesday 19 February 2025 6:30am to 9:30am
- Friday, 21 February 2025 10:30am to 12:00pm and 5:00pm to 6:30pm
- Saturday, 22 February 2025 6:00am to 2:30pm
- Sunday, 23 February 2025 6:30am to 11:00am

## Detail

The swim leg of various triathlon races will be conducted on the waters of Jervis Bay as specified above.

An **EXCLUSION ZONE** is specified during the event and will be indicated by the presence of course rounding buoys, with the zone extending for 50 metres outside the course rounding buoys on all sides.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by control vessels.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).
