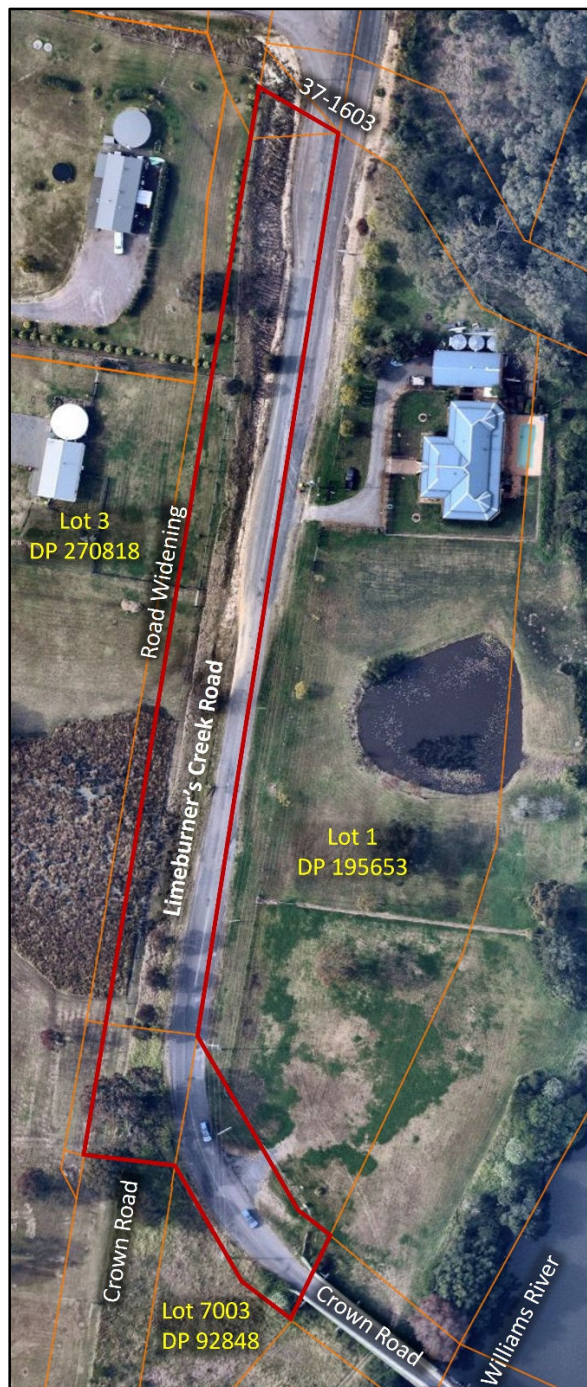
## Roads Act 1993, Section 16 Dedication of Land as Public Road
