Fisheries Management Act 1994

I, TARA MORIARTY MLC, Minister for Agriculture, impose a possession limit by order under section 17C of the *Fisheries Management Act 1994*.

# Part 1 Preliminary

## 1 Name of order

This order is the *Fisheries Management (Eastern Blue Groper Possession Limit) Order* 2025.

# 2 Commencement and duration

This order commences on 1 March 2025 and will remain in force for three calendar years.

#### **3** Definitions

In this order:

Eastern blue groper means the species of fish Achoerodus viridis.

possession limit has the meaning in section 17A(2) of the Act.

*recreational fisher* means a fisher who takes fish by any method, otherwise than for sale, but does not include an Aboriginal person carrying out Aboriginal cultural fishing.

#### Part 2 Possession limit

# 4 Recreational possession limit

In all circumstances, the possession limit for a recreational fisher for Eastern blue groper is zero.

# 1 Name of Notification

This notification is the Fisheries Management (Eastern Blue Groper Fishing Closure) Notification 2025.

### 2 Commencement and duration

This notification commences on 1 March 2025 and will remain in force for three calendar years.

#### **3** Definitions

In this notification:

Eastern blue groper means the species of fish Achoerodus viridis.

*recreational fisher* means a fisher who takes fish by any method, otherwise than for sale, but does not include an Aboriginal person carrying out Aboriginal cultural fishing.

A recreational fisher must not take Eastern blue groper.
