MURDER

FIVE HUNDRED THOUSAND DOLLARS (\$500,000) REWARD

The body of Jonathan Douglas MITCHELL, aged 28 years of age, was discovered on the floor of his home in Toongabbie on the 7 December 2003. Mr MITCHELL had suffered stab wounds to his neck and died as a result of those injuries.

Notice is hereby given that a reward of up to five hundred thousand dollars (\$500,000) will be paid by the Government of New South Wales for information leading to the arrest and conviction of the person or persons responsible for the death of Jonathan Douglas MITCHELL.

The allocation of this reward will be at the sole discretion of the Commissioner of Police.

DISAPPEARANCE

TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000) REWARD

On the 21 July 2005, Simon KNIGHT, aged 32 years, was last seen leaving the City Crown Hotel, Surry Hills, NSW. He has not been seen since and grave fears are held for his safety.

Notice is hereby given that a reward of up to two hundred and fifty thousand dollars (\$250,000) will be paid by the Government of New South Wales for information leading to the discovery of Simon KNIGHT's whereabouts or disclosing the circumstances of his disappearance.

**POISONS AND THERAPEUTIC
GOODS REGULATION 2008**

ORDER

Withdrawal of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation* 2008 an Order has been made on **Dr Vijai Gupta (MED0001070899)** of TOWRADGI NSW 2518, prohibiting him until further notice, as a medical practitioner, from supplying or having possession of drugs of addiction as authorised by clause 101 of the Regulation and issuing a prescription for a drug of addiction as authorised by clause 77 of the Regulation.

This Order is to take effect on and from 21 March 2025.
