Section 516(1A)

### ORDER

Maximum tariff for purposes of the definition of boarding house and lodging house

Under delegation from the Minister administering the *Local Government Act 1993*, I determine that for the period 1 July 2025 to 30 June 2026 (inclusive) the maximum tariff, exclusive of GST, for a boarding house or lodging house for the purposes of section 516(1A) of that Act is:

- (a) Where full board and lodging is provided-\$467 per week for single accommodation; or\$770 per week for family or shared accommodation.
- (b) Where less than full board and lodging is provided-\$315 per week for single accommodation; or\$518 per week for family or shared accommodation.

## NOTICE

Maximum interest on overdue rates and charges

Under delegation from the Minister administering the *Local Government Act* 1993, I specify, pursuant to section 566(3) of that Act, that for the period 1 July 2025 to 30 June 2026 (inclusive) the maximum rate of interest that may be set by a council in respect of rates and charges that remain unpaid after they become due and payable shall be 10.5 per cent per annum.
