I, the Honourable David Harris MP, Minister for Aboriginal Affairs and Treaty, following consent by the New South Wales Aboriginal Land Council (NSWALC), do, by this notice pursuant to section 231(2) of the Aboriginal Land Rights Act 1983 (the Act), extend the appointment of Mr Timothy Gumbleton as Administrator to Deerubbin Local Aboriginal Land Council (the Cobar LALC), for a period of 6 calendar months, effective from 28 February 2025. During the period of his appointment, the Administrator will have all the functions of the Deerubbin LALC, the Board of the Deerubbin LALC, and the members of the Deerubbin LALC exercised by resolution of the members of the Deerubbin LALC, and subject to section 230 of the Act, and any other duties as specified by the agreed terms of appointment. The Administrator's remuneration and expenses are not to exceed \$25,000 excluding GST per month, without the prior approval of NSWALC. The Administrator's remuneration may include fees payable for the services of other personnel within the Administrator's firm who provide services as agents of the Administrator.
