**MARINE NOTICE****REGULATION OF VESSELS – RESTRICTION OF SPEED OF VESSELS**

*Marine Safety Act 1998*  
*Section 11(1)*

**Location**

Statewide – all navigable waters of NSW.

**Duration**

- From 24 April 2025 to 12:00 midnight 30 June 2025.

**Regulation**

Pursuant to Section 11(2A)(a) and 11(3)(c) of the *Marine Safety Act 1998*, a **maximum speed restriction of 60 knots** (110 kilometres per hour) is temporarily imposed on all powered vessels towing any person of any age, in NSW navigable waters.

Penalties may apply (Section 11(4) - *Marine Safety Act 1998*).

This Notice does not derogate from any local waterway restriction on the towing of persons where a lower speed limit has been set, and any such local limit continues to apply.

**Explanatory Note**

For the safety of the public, Transport for NSW as delegate of the Minister has determined to limit the speed of any vessel towing any person in NSW navigable waters to 60 knots pending review of the waterway traffic arrangements for the State, in particular concerning the safety of persons involved in watersport activities.

Clause 46 of the *Marine Safety Regulation 2016* limits the speed of any vessel towing a person under the age of 18 to 60 knots. By this Notice, that regulation is effectively extended to cover any person of any age being towed.

## MARINE NOTICE

### PROHIBITION OR REGULATION OF VESSELS AND PERSONS IN WATERS

*Marine Safety Act 1998*  
*Section 18B*

#### Location

Minnamurra River – Entire width of the river between Trevethan Reserve and James Oates Reserve.

#### Duration

- 5:30am to 9:00am – Saturday 10 May 2025.

#### Activity or Event

The swim leg of a triathlon event will be conducted on the navigable waters of the Minnamurra River as specified above.

#### Exclusion Zone

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of large inflatable buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the time above.

Penalties may apply (Section 18B(4) - *Marine Safety Act 1998*).

## MARINE NOTICE

### PROHIBITION OR REGULATION OF VESSELS AND PERSONS IN WATERS

*Marine Safety Act 1998*  
*Section 18B*

#### Location

Byron Bay – from Wategos Beach to Byron Bay Surf Lifesaving Club at Main Beach.

#### Duration

- 9:00am to 12:00am – Sunday 4 May 2025.

#### Activity or Event

A coastal swim event will be conducted on the navigable waters of Byron Bay as specified above.

#### Exclusion Zone

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the event. The Exclusion Zone will be indicated by high visibility buoys, monitored by the presence of support vessels and patrolled by NSW Maritime vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 18B(4) - *Marine Safety Act 1998*).

**MARINE NOTICE**

**PROHIBITION OR REGULATION OF VESSELS AND PERSONS IN WATERS**

*Marine Safety Act 1998*  
*Section 18B*

**Location**

Wagonga Inlet, Narooma – within a 200 metre radius from a barge positioned approximately 300 metres west of the landmark of Quota Park and midway between Shell Point and Lavender Point.

**Duration**

- 7:00pm to 11:00pm – Friday 2 May 2025.

**Activity or Event**

A fireworks display will be conducted over the navigable waters of Wagonga Inlet, Narooma as specified above, and involves the use of a stationary barge as a launch platform. The area directly around the barge may be dangerous and hazardous while fireworks are being launched.

**Exclusion Zone**

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the event, which will extend 200m around the barge and will be maintained by event staff and monitored by the presence of a control vessel.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 18B(4) - *Marine Safety Act 1998*)

### PROHIBITION OR REGULATION OF VESSELS AND PERSONS IN WATERS

*Marine Safety Act 1998*  
*Section 18B*

#### Location

Hastings River – near the locality of Port Macquarie as follows:

- Ironman Practice Swims – between the Marine Rescue boat ramp and the downstream side of the Park Street Road bridge adjacent to the Broadwater Main Canal.
- Ironman Races – between the Marine Rescue boat ramp and the Broadwater Main Canal.

#### Duration

- 6:00am to 9:00am - Friday 2 May to Saturday 3 May 2025.
- 6:00am to 11:00am - Sunday 4 May 2025.

#### Activity or Event

An Ironman event will be conducted on the navigable waters of the Hastings River as specified above.

#### Exclusion Zone

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the events, which will be indicated and monitored by the presence of control vessels stationed around the perimeter.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

#### Transit Lane

Provision may be made (where necessary) for an event official to authorise local vessel traffic to pass safely through the Zone via a 'Transit Lane'.

#### Special Restrictions

Pursuant to Section 18B(2)(b) of the *Marine Safety Act 1998*, the following **SPECIAL RESTRICTIONS** are applicable to vessels using the transit lane:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Penalties may apply (Section 18B(4) - *Marine Safety Act 1998*)

**Exclusion Zone**

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the event which will be monitored and indicated by the presence of control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 18B(4) – *Marine Safety Act 1998*).
