1 Name of instrument

This instrument is the *Fisheries Management (TAF Committee Fishing Determination – Ocean Trap and Line Fishery) Notification 2025*.

2 Commencement

The fishing determinations in this notification take effect on the date the notification is published in the Gazette.

3 Definitions

In this instrument:

Bass Grouper means fish of the species *Polyprion americanus*

Bigeye Ocean Perch means fish of the species *Helicolenus barathri*

Blue-eye Trevalla means fish of the species *Hyperoglyphe antarctica*

Gemfish means fish of the species *Rexea solandri*

Hapuku means fish of the species *Polyprion oxygeneios*

Pink Ling means fish of the species *Genypterus blacodes*

Ocean Trap and Line Fishery means the share management fishery described in Schedule 1 of the *Fisheries Management Act 1994*

Ocean Trap and Line Fishery species means:

- (a) Bass Grouper (*Polyprion americanus*)
- (b) Bigeye Ocean Perch (*Helicolenus barathri*)
- (c) Blue-eye Trevalla (*Hyperoglyphe antarctica*)
- (d) Gemfish (*Rexea solandri*)
- (e) Hapuku (*Polyprion oxygeneios*)
- (f) Pink Ling (*Genypterus blacodes*)

TAC determination has the same meaning as in section 40A of the Act.

TAF committee means the Total Allowable Fishing Committee.

the Act means the *Fisheries Management Act 1994*.
