Notice of other criteria for competence to hold a practising certificate for statutory functions

I, **ANTHONY MARGETTS**, Chief Inspector, with the delegated authority of the Secretary, Department of Primary Industries and Regional Development, pursuant to section 138(2)(b) of the Work Health and Safety (Mines and Petroleum Sites) Regulation 2022 do, by this notice, specify for the purposes of satisfying the regulator of other criteria to grant a practising certificate in schedule 1, an individual is competent to exercise the statutory functions listed in column A (as prescribed in schedule 10 of the Regulation) if they hold one of the certificates of competence or qualification listed in column B.

**Explanatory Note:** Under section 138(2)(b) of the Work Health and Safety (Mines and Petroleum Sites) Regulation 2022, the regulator may be satisfied that an individual has the competence to exercise a statutory function if the individual meets other criteria specified by the regulator in respect of the function, by notice published in the NSW Government Gazette.
