# **Activity or Event**

High-speed power boat races will be conducted on the navigable waters of Fingal Bay, Port Stephens as specified above.

# **Exclusion Zone**

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the event, which will comprise the "competition area" set out in the attached map, marked by buoys and monitored by control vessels stationed around the boundary (see attached map).

# **Activity or Event**

Fireworks displays will be conducted on the navigable waters of Campbell Cove and east of Milsons Point.

### **Exclusion Zones**

Pursuant to Section 18B(2)(a), an **EXCLUSION ZONE** is specified during the event at both specified locations (see attached map) for the duration. The Exclusion Zone at Milsons Point will extend 125 metres around the fireworks barge and will also be monitored and indicated by the presence of control vessels. The Exclusion Zone at Campbells Cove will extend 50 metres around the Ship Dolphin and will be monitored and indicated by the presence of control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zones during the times above.



# **ROADS ACT 1993**

Order - Sections 46, 49, 54 and 67

# Shoalhaven City Council Area

Declaration as Controlled Access Road of part of the Princes Highway at Broughton and Berry

I, the Minister for Roads, by this order pursuant to Sections 46, 49, 54 and 67 of the Roads Act, 1993:

- 1. dedicate as public road the land described in Schedules 1 and 2 under;
- 2. declare to be a main road the said public road described in Schedule 2 and the public road described in Schedule 3 under;
- 3. declare to be a controlled access road the said main road described in Schedules 2 and 3;
- 4. declare that access to the said controlled access road is restricted; and
- 5. specify in Schedule 4 under, the points along the freeway at which access may be gained to or from other public roads.
