#### THREATENED SPECIES CONSERVATION ACT 1995

### Order extending biodiversity certification of the Growth Centres EPIs

I, Penny Sharpe, Minister for the Environment, extend the biodiversity certification of the Growth Centres EPIs for a period of one year, expiring on 30 June 2026.

This Order is made under clause 20 of Part 7 of Schedule 7 of the Act, continued by the operation of clause 43 of the *Biodiversity Conservation (Savings and Transitional) Regulation 2017* (NSW).

### Interpretation

In this Order:

Act means the Threatened Species Conservation Act 1995 (NSW); and

biodiversity certification of the Growth Centres EPIs means the biodiversity certification conferred by the enactment of Part 7 of Schedule 7 of the Act.

Growth Centres EPIs means the State Environmental Planning Policy (Sydney Region Growth Centres) 2006 and any other environmental planning instrument that applies to the subject land (being the land defined as such in clause 17(1) of Part 7 of Schedule 7 of the Act), as in force from time to time.
