**Point to Point Transport (Community Transport Passenger Service Levy Exemption)
Order 2025**

under the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017*

I, Josh Murray, Secretary of the Department of Transport, for and on behalf of Transport for NSW, pursuant to section 92(2) of the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017* make the following Order.

1 Name of order

This Order is the Point to Point Transport (Community Transport Passenger Service Levy Exemption) Order 2025.

2 Commencement

This Order commences on and from 1 July 2025.

3 Effect

This Order remains in force until 30 June 2027 and may be revoked by Transport for NSW at any time.

4 Interpretation

Words and expressions used in the Order have the same meaning as in the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016* or the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017* unless otherwise stated.

Commonwealth Home Support Program Community Transport Service: means a passenger service which, before 1 July 2025, had been provided under a community transport agreement with Transport for NSW to deliver transport services under the Commonwealth Home Support Program and who, from or after 1 July 2025, has an agreement with the Australian Government to provide those same transport services.

5 Exemption

A person is exempt from clause 3 of Schedule 4 of the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016* only when providing a Commonwealth Home Support Program Community Transport Service.

6 Publication

This Order is to be published in the NSW Government Gazette.

Explanatory note

The object of this Order is to continue to exclude community transport services that have been funded under the Commonwealth Home Support Program under a community transport agreement with Transport for NSW from the requirement to pay the passenger service levy for such trips until 30 June 2027.

This Order is made under section 92(2) of the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017*.
