

County of Fitzroy, Parishes of Ucombe & Wongawanga, about 1.4 hectares, being the unformed public road shown by red hatching in the diagram below.







County of Fitzroy, Parish of Bligh, about 0.05 hectares, being the public road shown by red hatching in the diagram below.




