Part 1 Preliminary

1 Name of Instrument

This instrument is the Fisheries Management (TAF Committee Fishing Determination – Eastern Rock Lobster) Notification 2025.

2 Commencement

The fishing determination in this notification takes effect on the date the notification is published in the Gazette.

3 Definitions

In this instrument:

Eastern Rock Lobster means fish of the species Sagmariasus verreauxi.

Lobster Fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

TAC determination has the same meaning as in section 40A of the Act.

the Act means the Fisheries Management Act 1994.
