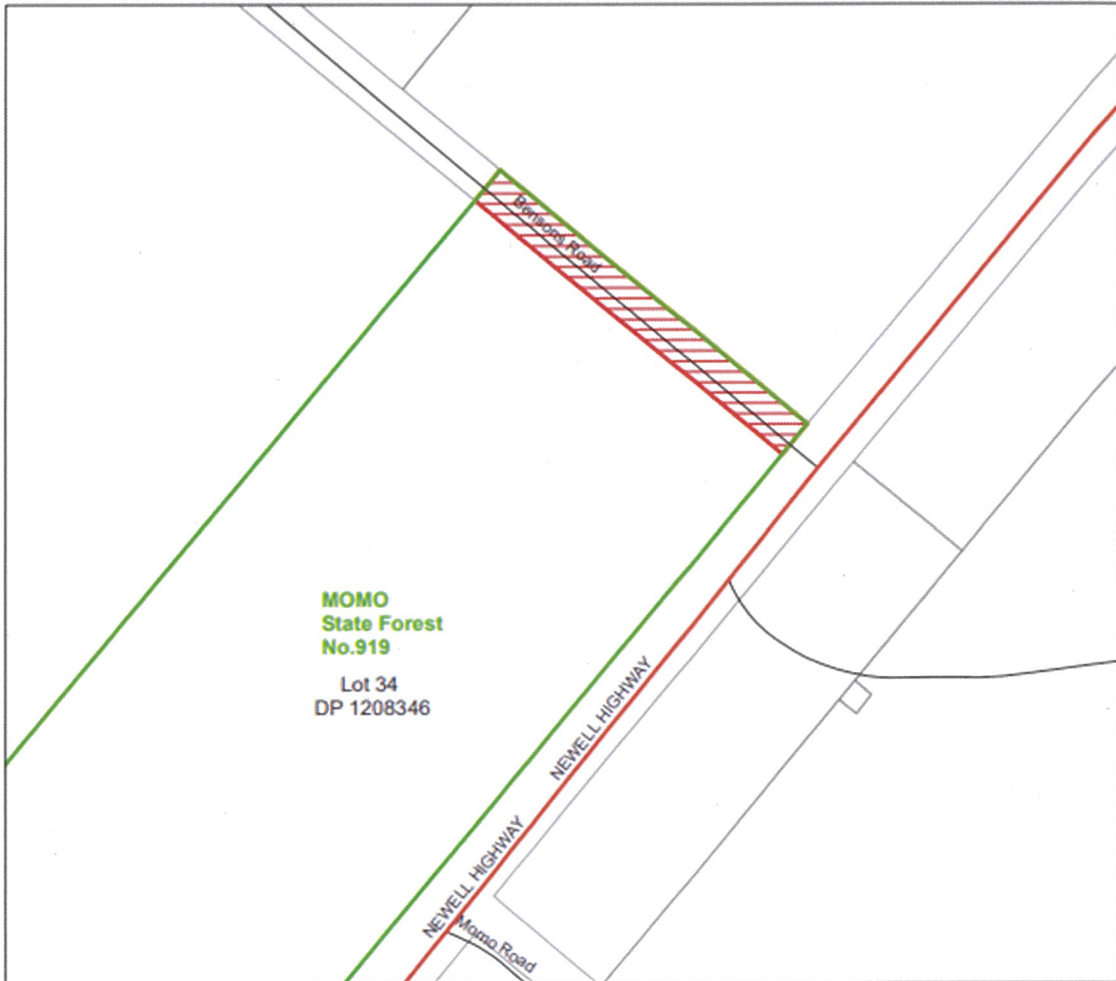

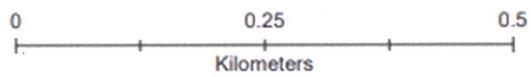
**Proposed revocation area
